
We have other important matters

ANGER AT OBAMA

Mississippi Republican Gov. Phil Bryant said: "This is the Texas, Utah and the governors of Maine and North Carolina. most outrageous example yet of the Obama administration forcing its liberal agenda on states that roundly reject it. saying: "President Obama's administration has instituted Public schools' restroom policies should not be shaped by federally mandated edicts that affect employees as well as

federal coercion."

This week, West Virginia Attorney General Patrick Morto guidance from President Barack Obama's administration's risey asked an appeals court to rehear a case that overturned a Virginia school district's policy forbidding a transgender teen from using the boys' restroom.

In the brief, West Virginia joined Arizona, Kansas, Nebraska,

North Carolina Gov. Pat McCrory released a statement

Washington Gov. IN TENNESSEE - Republican reaction to the directive was uniformly negative. State Senator Jeff Yarbro, D-Nashville, said, "If only we could get 26 state senators as excited about health care, transportation, or education as they are about bathrooms.' Education Committee Chairman U.S. Senator Lamar Alexander (R-Nashville) had this reaction from Washington regarding he Department of Education's guidance to local school districts regarding transgender student's use of public bathrooms: "This is the kind of issue that parents, school boards, communities, students and teachers should be allowed to work out in a practical way with a maximum amount of respect for the individual rights of all students. Insofar as the federal government goes, it's up to Congress to write the law, not the executive departments. And guidance issued by the departments does not amount to federal law and should not be treated as such."

Seven things I'm learning about transgender persons

I don't know much about transgender issues, but I'm trying to learn.

How about you? How much do you really know about this subject beyond all the screaming headlines and concerns about who goes to the bathroom where?

The truth is that I don't know any transgender persons — at least I don't think I do. But with the help of a pediatrician friend and a geneticist friend, I'm listening and trying to learn. This is hard, though, because understanding the transgender experience seems so far outside what I have ever contemplated before. And the more I learn, the more theological questions I face as well. This is hard, even for a pastor.

Here's some of what I'm learning from my friends who have experience as medical professionals dealing with real people and real families:

1. Even though LGBT gets lumped together in one tagline, the T is quite different than the LG and B. "Lesbian," "gay" and "bisexual" describe sexual orientation. "Transgender" describes gender identity. These are not the same thing. Sexual orientation is about whom we feel an attraction to and want to mate with; gender identity is about whether we identify as male or female.

2. What you see is not always what you get. For the vast majority of humanity, the presence of male or female genitalia corresponds to whether a person is male or female. What you see is what you are. But for a small part of humanity (something less than 1 percent), the visible parts and the inner identity do not line up. For example, it is possible to be born with male genitalia but female chromosomes or vice versa. And now brain research has demonstrated that it also is possible to be born with female genitalia, female chromosomes but a male brain. Most of us hit the jackpot upon birth with all three factors lining up like cherries on a slot machine: Our anatomy, chromosomes and brain cells all correspond as either male or female. But some people are born with variations in one or two of these indicators.

3. Stuff happens at birth that most of us never know. It's not an everyday occurrence but it's also not infrequent that babies are born with ambiguous or incomplete sexual anatomy. In the past, surgeons often made the decision about whether

this child would be a boy or a girl, based on what was the easiest surgical fix. Today, much more thought is given to these life-changing decisions.

4. Transgender persons are not "transvestites." Far too many of us make this mix-up, in part because the words sound similar and we have no real knowledge of either. Cross-dressers, identified in slang as "transvestites," are people (typically men) who are happy with their gender but derive pleasure from occasionally dressing like the opposite gender. Cross-dressing is about something other than gender identity.

5. Transgender persons are not pedophiles. The typical profile of a pedophile is an adult male who identifies as heterosexual and most likely even is married. There is zero statistical evidence to link transgender persons to pedophilia.

6. Transgender persons hate all the attention they're getting. The typical transgender person wants desperately not to attract attention. All this publicity and talk of bathroom habits is highly disconcerting to people who have spent their lives trying not to stand out or become the center of attention. 7. Transgender persons are the product of nature much more than nurture. Debate the origins of homosexuality if you'd like and what role nature vs. nurture plays. But for those who are transgender, nature undeniably plays a primary role. According to medical science, chromosomal variances occur within moments of conception, and anatomical development happens within the nine months in the womb. There is no nature vs. nurture argument, except in cases of

brain development, which is an emerging field of study. This last point in particular raises the largest of theological questions. If Christians really believe every person is created in the image of God, how can we damn a baby who comes from the womb with gender dysphoria? My pediatrician friend puts it this way: "We must believe that even if some people got a lower dose of a chromosome, or an enzyme, or a hormonal effect, that does not mean that they got a lower dose of God's image."

I don't know much about transgender issues, but I'm trying to learn — in part because I want to understand the way God has made us. For me, this is a theological quest as much as a biological inquiry or a political cause. How about you?



Don't get me started on the sleazy advertising possibilities for Valley Forge. ("The Father of Our Country...on dollar bills. Dollar bills...in G-strings. What could be more natural?") Other concerned citizens worry more that park managers will be devoting too much of their time to fundraising. I can just imagine park rangers using a tranquilizer gun on a potential sponsor. ("Now, now - slow down and let's talk this over before you give all your money to PBS.") Yes, park officials will be tempted to give up on studying the mating rituals of migratory birds and start studying the mating rituals of CEOs. ("Couldn't help but notice you and the showgirl getting out of Motel 6. Perhaps for a small donation this photo could disappear before it reaches your wife ... In my 62 years, I have only been away from Lawrence County for short periods of time. I attended college and worked with my father's company in Arkansas for one year, but even those opportunities were outmatched by my desire to be home.

I am proud of Lawrence County for many reasons. One is the simple fact that after

Lawrence Countians became friends with German soldiers being held here as Prisoners of War, and the Stribling-Brock family continued to correspond with several of them through the 1970s.

That collection of letters, cards and photographs was discovered in the late 1980s, but they remained mostly unread because they were written in an older German dialect. Then local historian Curtis Peters, a son-in-law of the Stribling-Brock family, was introduced to a Lipscomb University professor who was here studying our Mexican War monument.

One thing led to another, and Lipscomb's Departments of History and German became involved. The Stribling-Brock family agreed to donate the correspondence to the University's Beaman Library, so they could be studied by scholars there and be available to the public.

As German language students translated the letters, they

• You worry about her more often than you used to - Do you check on her more often or call her regularly regarding her safety and location?

You Can No Longer Manage Mom's Health Care Needs:

If Mom has started to need your constant supervision with her food and her medications; it might be time to seek memory care for her. People with Alzheimer's and dementia often get confused when it comes to medication management and proper nutrition. If you are just starting to notice small things, like a missed dose here or there, food left on the counter that she forgot to refrigerate, or several missed meals entirely, those are all red flags. It can be very difficult to keep a parent with Alzheimer's or dementia from being or from feeling isolated. When this happens, it becomes difficult to take Mom out to shop, to eat, or to any other social gatherings. Not being able to take Mom out will result in her becoming lonely and restless. This is definitely a time to look for memory care for Mom.

You Have Caregiver Burnout: Caring for someone, especially someone with Alzheimer's or dementia, is emotionally and physically draining. Being a caregiver for someone with dementia can cause feelings of helplessness, hopelessness, and guilt. Caregiver burnout is real, and <u>the</u> signs should not be ignored.
